Indeks Harga Saham Gabungan Senin (5/9) naik 0,1% ke posisi 5356,95, demikian saham-saham unggulan pada indeks LQ45 naik 0,1% ke posisi 920,13. Sepanjang perdagangan IHSG kemarin sempat menyentuh level terendah 5348 dan level tertinggi 5397.

Analyst Vibiz Research Center melihat secara teknikal Indeks Harga Saham Gabungan (IHSG) bergerak positif dalam penguatan terbatas.

Kekuatan naiknya harga minyak mentah cukup tinggi hingga mengangkat bursa Eropa semalam akan memberikan semangat bagi bursa Asia juga Indonesia.


